By letter dated 9/6/2021 the K.D. Gavit College of B.Sc. Nursing Patharai Dist. Nandurbar has requested the Authority to approve the fee for the academic year 2020-21 for the B.Sc. Nursing course run by the said Institute.

On receipt of the letter the institution was directed to submit the proposal for approval of fees in a prescribed proforma alongwith requisite documents such as audited financial statement of the previous year. Although the Institute has submitted the proposal in prescribed proforma but could not submit the requisite documents as the Institute/College was not functioning during the period 2009-2019. The Institute/college is claiming that the Maharashtra University of Health Science Nashik (MUHS) has allowed them to admit the students for the academic year 2020-21.

Considering the difficulties faced by the Institution, it was decided to allow the Institute/College to collect the Ad-hoc fees @ of Rs. 65,000/- per student for the B.Sc. Nursing course (i.e. the adhoc fees notified by the Authority for the academic year 2021-22).

It is clarified that the approval of adhoc fees is subject to condition that the Institute/College shall submit the proposal in prescribed proforma with requisite document for the academic year 2022-23. In case the fees finally work out for academic year 2022-23 found to be less than the Ad-hoc fee then, the Institute/College shall be liable to refund the same to the students.

Item No. 3(ii): To consider the proposal for approval of fees from K.D. Gavit College of Physiotherapy Patharai Dist. Nandurbar for the academic year 2020-21.

By letter received on 10/6/2021, K.D. Gavit College of Physiotherapy Patharai Dist. Nandurbar has requested the Authority to approve the fee for the academic year 2020-21 for the Physiotherapy course run by the said Institute.

On receipt of the letter the institution was directed to submit the proposal for approval of fees in a prescribed proforma alongwith requisite documents such as audited financial statement of the previous year. Although the Institute has submitted the proposal in prescribed proforma but could not submit the requisite documents as the Institute/College was not functioning during the period 2009-2019. The Institute/college is claiming that the Maharashtra University of Health Science Nashik (MUHS) has allowed them to admit the students for the academic year 2020-21.

Considering the difficulties faced by the Institution it was decided to allow the Institute/College to collect the Ad-hoc fees @ of Rs. 80,000/- per student for the Bachelor of Physiotherapy course (i.e. the adhoc fees notified by the Authority for the academic year 2021-22).
